**POLISI PERLINDUNGAN CERUN DAN SUNGAI**

Far East Holdings Berhad (“FEHB” atau “Syarikat”) komited untuk perlindungan alam sekitar dan memelihara cerun dan sungai seperti yang dinyatakan di bawah:-

- **Perlindungan Cerun**

Kawasan yang berkecerunan  $> 25^\circ$  mesti dikecualikan daripada sebarang aktiviti pembangunan perladangan dan penanaman semula.

Untuk cerun  $< 25^\circ$ , tanaman kontan dan tutup bumi sedia ada perlu dikekalkan sewajarnya.

Penanaman pokok hutan untuk memperkayakan spesis adalah disyorkan.

Penanaman kacang tutup bumi adalah diwajibkan bagi kawasan dengan kecerunan  $> 7^\circ$ .

- **Zon Penampan Sungai**

Zon penampan harus dikekalkan di kedua-dua belah tebing sungai seperti jadual di bawah:-

Lebar Sungai (m)	<5	5-10	11-20	21-40	>40
Zon Penampan (kedua-dua belah tebing sungai)	5m	10m	30m	40m	50m

- atau mengikut peruntukan peraturan dan undang-undang setempat.

Kawasan sedia ada yang tidak memenuhi kriteria di atas wajib mematuhi garis panduan ini semasa aktiviti penanaman semula di masa akan datang.

- **Inisiatif Kawalan Pencemaran Sungai.**

Mengamalkan GAP (Good Agriculture Practice) dalam operasi perladangan dengan mengambilkira potensi pencemaran terutama dalam pembinaan jalan, teres atau parit, pengurusan pembajaan dan penggunaan bahan kimia dalam pengawalan rumpai dan makhluk perosak.

**SLOPE & RIVER PROTECTION POLICY**

Far East Holdings Berhad (“FEHB” or “Company”) is committed to protecting the environment and preserving slopes and rivers as set out below:-

- **Slope Protection**

Areas that are steep  $> 25^\circ$  must be exempt from any plantation development and replanting activities.

For slope that is  $< 25^\circ$ , existing cash crops and earth cover should be maintained accordingly.

Forest plantation to increase the species is recommended.

The planting of legume cover is compulsory for area with gradient  $> 7^\circ$ .

- **River Buffer Zone**

The buffer zone should be maintained on both sides of the riverbank as shown below:-

River's Width (m)	<5	5-10	11-20	21-40	>40
Buffer Zone (both sides of the riverbank)	5m	10m	30m	40m	50m

- or in accordance with the provisions of local laws and regulations.

Existing areas that doesn't meet the criteria above must comply with these guidelines during replanting activities in the future.

- **River Pollution Control Initiative**

GAP (Good Agriculture Practice) practice in plantation operations in order to take into account concerning the risk of pollution especially in the construction of roads, terraces or drains, fertilization management and the use of chemicals in weed control and pests.
